# A message from Chief Executive Hannah McCaughey

As the newly appointed Chief Executive for EnergyCo, I'm honoured to step into this role at what is an exciting time for the Central-West Orana REZ.

This year we secured full planning approval for the REZ, making it the first in Australia to reach this historic milestone. This is a major step forward in our mission to deliver a clean, reliable and affordable energy future for NSW.

Another key highlight was the Minister for Energy Penny Sharpe granting ACEREZ the licence to design, construct and operate approximately 240 kilometres of transmission lines and supporting infrastructure that will connect our renewable energy projects within the REZ. This is a vital step to delivering at least 4.5 gigawatts (GW) of transmitted electricity, helping to drive the state's energy transition.

We are delivering on our commitment to engaging and supporting the communities we work with. This year we hosted workshops to identify local priorities that helped shape the Community and Employment Benefit Program, which launched in the Central-West Orana REZ in July.

The local community will receive \$128 million over the next four years, with an initial \$70 million now available to community groups, councils and First Nations organisations.

We also supported communities applying for funds through free grant-writing workshops, ensuring local and Aboriginal stakeholders can fully benefit from the opportunities created by the REZ.

As we embark into the delivery stage of the transmission project, we are working alongside the preferred network operator to promote work opportunities, strengthen relationships and mitigate impacts through ongoing engagement with landowners, councils and Aboriginal communities.

The road ahead is exciting, and I look forward to continuing this important work together as we move into 2025.

## Major milestones

Response to Submissions and Amendment Report

Following the exhibition of the Environmental Impact Statement (EIS) in late 2023, more than 400 submissions were received.

EnergyCo reviewed these and prepared a Response to Submissions and Amendment Report published in March 2024.

The Central-West Orana REZ transmission project secured full planning approval from the Commonwealth and NSW Government, making it the first REZ in Australia to reach this pivotal milestone. The construction of essential transmission infrastructure brings us closer to connecting large-

scale solar, wind and energy storage projects to the electricity grid.

At its peak, the project will generate \$20 billion in private investment, support around 5,000 construction jobs and deliver \$3 billion in net benefits for NSW energy consumers.

#### Preferred network operator secured

ACEREZ, a consortium of ACCIONA, COBRA, and Endeavour Energy, was confirmed as the preferred network operator in December 2023. Final contracts are expected to be awarded and construction is set to begin in early 2025.

# ACEREZ granted transmission operator's licence

We are one step closer to delivering electricity into the grid after ACEREZ was granted a transmission operator's licence for the Central-West Orana REZ transmission system. The licence, granted by the Minister for Energy in September 2024, will enable ACEREZ to design, construct, own and operate the Central-West Orana REZ transmission system.

#### **Biodiversity offsets**

We are balancing energy development with strategic conservation by securing Biodiversity Stewardship Agreements (BSA) across the community, protecting crucial ecosystems like Box-Gum Woodland and threatened habitats such as the Regent Honeyeater.

Two large properties adjoining Capertee and Goulburn River national parks have been acquired, boosting conservation and ecological connectivity in the region.

We're building long-term land stewardship and promoting regional sustainability by collaborating with landholders and stakeholders.







## **Building stronger communities**

Thank you to those who submitted applications to receive funding under the Community and Employment Benefit Program (the Program) for the Central-West Orana REZ. Applications are being independently assessed by the Department of Primary Industries and Regional Development. Successful projects will be announced in early 2025.

# **Local Community Small Grants** projects

This grant stream is designed to support small-scale events, initiatives or projects that deliver tangible benefits for residents, local organisations and First Nations communities in the REZ. The program will continue long after the REZs are delivered and will invest hundreds of millions of dollars into regional communities delivering lasting benefits. ## Engaging with you at each step

We could not have reached this milestone without the support and active engagement from our stakeholders and communities this year.

#### **Identifying local priorities**

In February and March, we worked with you to identify community priorities through a survey, targeted workshops and local information sessions, gathering feedback from over 300 people. Outcomes from this consultation helped refine the Program. Read the key findings on our website.



#### Launch of Community and Employment Benefit Program tranche 1

In July, the NSW Government launched the first tranche of the Community and Employment Benefit Program that will deliver an initial \$128 million to communities in the Central-West Orana REZ over the next four years. Under tranche 1, \$70 million in funding has been made available across four grant streams.

#### Workshops

To support the community in applying for grants and work packages, EnergyCo and ACEREZ hosted free grant-writing workshops, attended by nearly 80 participants. Recordings are available online for those who missed the sessions.



#### Forum focuses on youth career paths

EnergyCo, in partnership with the preferred network operator for Central-West Orana REZ, ACEREZ, was proud to sponsor the inaugural Regional Development Australia Orana Youth Forum in Dubbo on 6 November. The Youth Forum is an initiative aimed at equipping young people with the skills and knowledge necessary to start a future career in renewable energy. This collaboration highlighted a shared commitment to empowering the next generation in the Central-West Orana region.

## Upskill for the energy transition

EnergyCo collaborated with TAFE NSW and industry partners to develop the 'Prepare to work in the renewable energy industry' microskills course, launched in November 2024. This introductory course is designed to boost local workforce skills by providing information on how to kick-start a career in clean energy.

# Boosting the region's economy Investment surge

The Clean Energy Finance Corporation (CEFC) confirmed a \$490 million investment into the REZ through the Rewiring the Nation Fund. This landmark contribution will not only support the grid's development but also save NSW consumers an estimated \$240 million over the next 20 years.

#### Initial work packages released

Tenders for early work activities such as drainage, fencing, and other elements of construction for the transmission lines were announced in July. EnergyCo and ACEREZ hosted 11 industry forums across the region, attended by about 300 participants from local businesses. These forums opened doors to tender opportunities, networking and business support across the region. More packages will be released over the next year. 

# Community and Employment Benefit Program drop-ins


To help design a program that reflected community priorities, we held eight drop-in sessions across the region during February and March this year.

#### **Dubbo Show**

EnergyCo hosted a stall at the Dubbo Show held from 10-12 May 2024. Sharing information with local community members about the transmission project.

#### Indigenous Business Summit 2024

EnergyCo celebrated Aboriginal business excellence at the Indigenous Business Summit in the Hunter during November 2024. We spoke to representatives from a diverse range of Aboriginal businesses, including law firms, employment consultants, contractors, and artists at the tradeshow.

#### Port to REZ

We are working with Transport for NSW to upgrade road intersections and pinch-points between the Port of Newcastle and the Central-West Orana REZ and Hunter-Central Coast REZ.

Detailed maps have been released showing the 19 highway upgrades along this route. These improvements will allow oversized over mass vehicles to transport heavy renewable energy components. This includes wind turbine components and transformers needed for generation and transmission infrastructure.

Our ongoing consultation with impacted landowners will continue to ensure a collaborative and transparent approach as the project progresses.
