Central-West Orana Community and Employment Benefit Program

The Community and Employment Benefit Program which will invest millions of dollars into communities in the Central-West Orana Renewable Energy Zone (REZ) over the next four years to deliver community projects and employment opportunities.

The Program has been developed in consultation with councils, community and First Nations organisations and other stakeholders by identifying community priorities with the aim to create long-term legacy programs in the region. There are four funding streams: the First Nations Fund, the Legacy Infrastructure Fund, the Local Community Fund, and Local Community Small Grants.

First Nations Fund

While all four grant streams are open to Aboriginal applicants, the First Nations Fund is a dedicated stream of \$10 million. Within this are two categories. Projects can be submitted and assessed every six weeks.



LALC Support Up to \$4 million available

Supports the Local Aboriginal Land Councils to build capability and better protect and further the aspirations of their members and the broader Aboriginal community.



Aboriginal Outcomes Up to \$6 million available

Supports Aboriginal organisations to drive local initiatives that result in economic, social or environmental outcomes for Aboriginal communities.

Applications for either stream can be for a minimum funding amount of \$50,000 and up to a maximum funding amount of \$500,000 (GST exclusive). The aim of this fund is to build capacity of First Nations organisations through programs, services, infrastructure, or activities that are designed to reflect local needs and provide lasting benefits. All eligible projects must be delivered within the Central West Orana REZ boundary or provide primary benefit to local communities in the Central-West Orana REZ. How to apply

EnergyCo, with NSW Department of Primary Industries and Regional Development, will support applicants in developing and submitting their application. The application form is in two parts. Part A will require applicants to answer a series of questions in relation to eligibility. Part B covers the more detailed aspects of the project. The Energy Corporation of NSW (EnergyCo) is a statutory authority responsible for leading the delivery of Central-West Orana Renewable Energy Zone (REZ). The Central-West Orana REZ is a new network of transmission towers, lines and energy hubs. These transfer power generated by solar and wind farms owned by independent developers, to consumers. EnergyCo is the Infrastructure Planner for this new transmission network.
